



## FABILIVE SUB-MERCHANT AGREEMENT FOR DELIVERY COMPANY

This **Sub-Merchant Delivery Agreement** (“Agreement”) is made between **Fabilive Online Marketplace** (“Platform”) and the approved **Delivery Company** (“Company”).

### 1. Purpose of the Agreement

The Company is authorized by Fabilive to deliver items purchased by buyers on the Fabilive Online Marketplace.

Once a delivery assignment is accepted by the Company, it becomes legally binding. The Company agrees to complete the delivery in accordance with:

- Applicable laws
- Platform policies and standards
- Professional delivery practices

### 2. Delivery Obligations

- The Company must complete all assigned deliveries responsibly and lawfully.
- All delivery tasks must be completed within **12 hours maximum**.
- The Company must ensure that packages are delivered safely to the correct recipient.

### 3. Package Integrity

- The Company shall **NOT OPEN, INSPECT, or TAMPER** with any package.
- The seal and condition of the package must remain exactly as received from the Seller.
- Any violation of this obligation may result in legal action.

### 4. Breach of Agreement

Failure to deliver a package without valid justification shall be considered a **breach of this Agreement**.

In such cases:

- The Company may be held legally liable.
- The affected party may seek legal remedy before a court of law.

### 5. Liability & Compensation

If delivery failure, negligence, misconduct, or deliberate wrongdoing by the Company or its staff causes:

- Loss
- Damage
- Dispute

The Company shall reimburse the affected party accordingly.

### 6. Pay-Out Terms

All approved pay-out or withdrawal requests shall be processed within **24 hours maximum** from the time of request. Bank transactions will be successful within 24 hours to 72 hours maximum.

## 7. Earning and Fee Entitlement

By providing delivery services through FabiLive, the company agree that they will receive **80% of the total delivery fees earned** from completed deliveries. FabiLive will retain **20% of the total amount** as a service, platform maintenance, and transaction processing fee.

Earnings from completed deliveries will be credited to the companies Fabilive account and made available for withdrawal in accordance with FabiLive's payout policies.

## 8. Termination

This Agreement may be terminated at any time by either party through written notice.

## 9. Governing Law

This Agreement shall be governed by and interpreted under the **Laws of Cameroon.**

## 10. Acceptance

By signing this Agreement with Fabilive, the Delivery Company confirms that it:

- Has read this Agreement
- Fully understands its terms
- Agrees to comply with all conditions stated herein
